



# The Law360 400: Tracking The Largest US Law Firms

Law360 (May 21, 2024, 2:04 PM EDT) -- The legal market expanded more tentatively in 2023 than in previous years amid a slowdown in demand for legal services, especially in transactions, an area that has been sluggish but is expected to quicken in the near future.

Nevertheless, the largest U.S. law firms by headcount still managed to grow their ranks, expanding at an average rate of 2.2% overall, with the top 50 outpacing the others.

The 50 largest firms grew at an average rate of 2.9% and the 200 largest firms at 2.6% — both several percentage points above the 2.2% overall average — while the 200 firms in the lower half of the ranking grew at 1.4%.

Although law firm hiring has clearly slowed, growth has not stopped but is returning to a pace comparable to that of the years preceding the pandemic. Many BigLaw leaders remain **cautiously optimistic** about prospects for growth.

Kirkland & Ellis LLP has once again earned the title of the biggest U.S. law firm, as it has every year since 2018. Latham & Watkins LLP and Greenberg Traurig LLP placed second and third, just as they have since 2018. Holland & Knight LLP jumped from eighth to fourth after swelling its ranks through a merger with Waller Lansden Dortch & Davis LLP.

And Gibson Dunn & Crutcher LLP broke into the top 10, knocking Lewis Brisbois Bisgaard & Smith LLP down to 11th place. Lewis Brisbois, Sidley Austin LLP, Morgan Lewis & Bockius LLP and Goodwin Procter LLP all saw their headcounts shrink in 2023, while Jones Day saw its headcount grow for the first time in two years.

Mergers accounted for much of the growth at firms of 100 or more attorneys in 2023. But midsize firms are **combining at greater rates** than ever before, so we can expect to see more growth among the firms ranked 201-400 in 2024.

The Law360 400 features the largest U.S.-based law firms and international firms with a U.S. component as measured by domestic attorney headcount.

\*Firms either declined to provide headcount information or did not respond by the survey deadline. Law360 estimated the headcount data for those firms using the firms' websites.

*Methodology: Law360 gathered data from U.S. law firms and vereins or similar structures with a U.S. component, collecting domestic attorney and partner headcount information as of Dec. 31, 2023. Firms based outside the U.S. are not included, and only attorneys based in the 50 states and the District of Columbia were included in the responses. Firms that have shareholders, members or principals in lieu of partners have those numbers listed in the "partner" column.*

*Firms are ranked by their total number of U.S. attorneys. For firms with identical total U.S. headcounts, Law360 breaks ties by reviewing the percent change in attorney headcount from the previous year or years, if necessary. For the firms where that data is unavailable, Law360 assumes the percent change is zero for the purposes of breaking those ties only.*

*Ulmer & Berne LLP and Greensfelder Hemker & Gale PC merged effective February 1, 2024. Data for both firms is as of Dec. 31, 2023, premerger.*

*Shearman & Sterling and Allen & Overy merged effective May 1, 2024. Data for Shearman & Sterling is as of Dec. 31, 2023, premerger.*
